RED PHASE	<ul> <li>All budget funds available are centralized and directed towards supporting the ECP and necessary COVID-19 items (Includes centralized curriculum)</li> <li>All building and department budgets are not available for site-based spending</li> <li>All grant funds including site-based allocations are centralized and directed towards supporting the ECP unless already appropriated for continuation of services</li> <li>Activities and services to support the Senior Class are allowable (through June 30)</li> <li>New contracts are not allowable without the pre-approval from the CFO</li> <li>Warehouse orders are not allowable unless needed for essential services to support the ECP</li> <li>Offsite professional development and/or travel requisitions are not allowable</li> <li>Online professional development is allowable, with the approval of your supervisor, not to exceed \$250</li> <li>Employee tuition costs for reimbursement are allowable</li> <li>Extra pay for professional staff, including co-curricular, is not allowable without pre-approval from the CFO</li> <li>Non-mandated costs will not be allowable</li> <li>Urgent requests should be submitted to CFO with reason for need and cost of items or services</li> </ul>
YELLOW PHASE	<ul> <li>Building and department budgets available for site-based spending at 50% original budgeted levels (pending state budget approval)</li> <li>All grant funds including site-based allocations are centralized and directed towards supporting the ECP unless already appropriated for continuation of services</li> <li>New contracts for services may be approved based on need and alignment to district budget priorities</li> <li>Warehouse orders are allowable</li> <li>Field trip and transportation requests are not allowable</li> <li>Online professional development is allowable, with the approval of your supervisor, not to exceed \$250</li> <li>Offsite professional development and/or travel requisitions are not allowable</li> <li>Extra pay for professional staff, including co-curricular, is not allowable without pre-approval from the CFO</li> <li>Urgent requests should be submitted to CFO with reason for need and cost of items or services</li> </ul>

ORANGE PHASE (Governor's Green Phase w/ Restrictions for COVID- 19)	<ul> <li>Building and department budgets available for site-based appropriation at 85% original budgeted levels based on the district's budget priorities</li> <li>All grant funds including site-based allocations are appropriated at 85% for operations based on the district's budget priorities</li> <li>Extra pay and support staff overtime is allowable based on contract guidelines and pre-approval from building/department supervisors</li> <li>Continued monitoring of all budget cost centers to determine if additional limitations are necessary to support the economic condition</li> <li>New contracts for services may be approved based on need and alignment to district budget priorities</li> <li>Online only professional development is allowable</li> <li>Professional development or travel may be allowable with certain restrictions due to budget and Government guidance</li> <li>Field trip and transportation requisitions may be permitted based on alignment to district's educational priorities</li> </ul>
GREEN PHASE (Normal Operations No COVID-19 Restrictions)	<ul> <li>Restore budgets, process, and procedures to pre-COVID-19 state</li> <li>Building and department budgets available for site-based appropriation at 100% original budgeted levels</li> <li>All grant funds including site-based allocations are appropriated at 100%</li> <li>Extra pay and support staff overtime is allowable based on contract guidelines and pre-approval from building/department supervisors</li> <li>New contracts for services are to be submitted through standard process</li> <li>Professional development or travel to follow standard process</li> <li>Field trip and transportation requisitions to follow standard process</li> </ul>
